Schedule

- Successful candidates in the 1st round of foreign-student admissions can begin the program in either September 2016 or April 2017.
- Successful candidates in the 2nd round of foreign-student admissions can begin the program in either April 2017 or September 2017.
- The standard term of study is two years, but this can be extended to three in certain cases. (Those preferring the three-year option must receive prior approval from the School.)

Application Requirements

Notes: 1) Those intending to submit applications for the Master's Program in Food and Nutrition must consult beforehand with their preferred advisor-instructor. Inquire to the Sugiyama Admissions Office (toll-free 0120-244-887) to confirm the details no later than one week before the start of the application period.

2) Those applying under the Foreign Student Special Admissions Program must have their applications evaluated to determine whether they meet all of the requirements for application. Be sure to submit the necessary documents to the Sugiyama Admissions Office by the specified deadline.

- An applicant must be a female without Japanese citizenship who is qualified to obtain a "foreign student" visa in accordance with the provisions of the Immigration Control and Refugee Recognition Act of Japan, and who is one of the following:

1. a university graduate (or expected to graduate prior to the admission of the graduate school).
2. the holder of a Bachelor's degree
3. one who has completed a minimum of 16 years of formal education in a foreign country
4. one who has been selected by the Minister of Education, Culture, Sports, Science, and Technology in accordance with Article 155, Paragraph 1, Item 6 of the Enforcement Regulations for the School Education Law (Ministry of Education Ordinance 11, 1947)
5. one who is 22 years of age, and determined by the Graduate School Committee to have academic ability equivalent to that of a Japanese university graduate (determination thereof based on the Committee's individual evaluation of the applicant's qualifications)
6. one who has been determined via means other than those in (5) by the Graduate School Committee to have academic ability equivalent to that of a Japanese university graduate

Selection Process

Selection will be based on the combined results of a written test and an interview, as well as an evaluation of the content of the necessary forms submitted by the applicant.

2) Those applying under the Foreign Student Special Admissions Program must have their applications evaluated to determine whether they meet all of the requirements for application. Be sure to submit the necessary documents to the Sugiyama Admissions Office by the specified deadline.

- An applicant must be a female without Japanese citizenship who is qualified to obtain a “foreign student” visa in accordance with provisions of the Immigration Control and Refugee Recognition Act of Japan, and who is one of the following:
 1. a holder of a Master’s degree, or scheduled to complete a Master’s program before entering the Graduate School of Life Sciences
 2. a holder of a foreign equivalent of a Japanese Master’s degree
 3. one who has been determined by the Graduate School Committee to have academic ability equivalent to that of a Japanese Master’s degree holder

Selection Process

Selection will be based on the combined results of a written test and an interview, as well as an evaluation of the content of the necessary forms submitted by the applicant.
